Discover Dubai Itinerary

Day 1: Overnight Flight to Dubai

Board your overnight flight to Dubai.

Day 2: Arrive Dubai, United Arab Emirates (UAE)

Arrive in Dubai and meet your **Local Trip Expert/Guide**. Transfer to your hotel to check in for a five-night stay in this amazing city. Dubai is a city of ages that rises out of the desert and crowns the gulf coast with its presence.

Next, experience a traditional Emirati lunch at the **Sheikh Mohammed Centre for Cultural Understanding**, in one of the oldest Emirati neighborhoods in Bur Dubai. Enjoy a meal while chatting with an Emirati host about UAE culture, customs and religion. Later, travel to the top of the tallest building in the world, the **Burj Khalifa**. Enjoy a **Welcome Dinner** with your fellow travelers.

Day 4: East Coast Tour

Today travel to the East Coast of the UAE. Enroute pass through the agricultural areas of **Al Dhaid** and see the terrain change from colorful desert landscape to spectacular mountain scenery. The coastline is scattered with small fishing villages including the old village of **Dibba**, once a strategically important settlement with a stunning view across the Indian Ocean. Continuing along the coastline, we arrive at the **Al Bidya Mosque**, the oldest mosque in the country, built in the 15th century. Then we pass the port towns of **Khorfakhan** and **Fujairah**, the ruins of the mountain dwellers, the 300-year-old **Fort of Fujairah**, and the fortress of nearby **Bithnah Oasis**. Return to Dubai and enjoy the evening at leisure.

Day 5: Abu Dhabi Tour

Today from Dubai travel past the world's largest man-made port at **Jebel Ali** enroute to **Abu Dhabi**. Then visit the **Cultural Foundation**, in the heart of the city next to the famous Union Square, that gathers symbolic themes inspired by the customs of the country. After a drive along the Corniche, visit the **Heritage Village**, specially designed by late HH Sheikh Zayed Ben Sultan al Nahyan as a reminder of the past for the younger generation. Enjoy a **Dhow Dinner Cruise**, a traditionally decorated wooden boat that will sail along the Dubai Creek under the moonlight.
